The Forum

This signature event was held at Hennessy Park Hotel, in Ebene, Mauritius on Thursday 16th November, 2017. The holding of the Forum came at a point when Halley Movement ended with its Good Digital Parenting project, conducted for the past two years and the event brought in another dimension to child protection in Mauritius.

This event gathered key State and Non-State actors from the fields of Internet Governance and child protection in Mauritius. It grouped a selected audience of experts coming from civil society organisations, IT industry, academia people, technical community and the corporate sector.

Mauritius IGF was officially launched at the opening ceremony.

Objectives

Mauritius IGF event was in line with Internet Governance Forum objectives, which included:

- To advance internet governance issues in Mauritius through a multi-stakeholder framework as well as facilitating partnerships and coalitions that deliver coordinated domestic responses, initiatives, and synergies,
- To increase awareness and build capacity development on internet governance issues in Mauritius so as to ensure informed dialogue on policy and related matters between all stakeholders,
- To establish a coordinated and coherent framework for dealing with internet governance issues in Mauritius,
- To facilitate the participation of a broad range of stakeholders in internet governance issue,
- To ensure that Mauritius views are represented in the region and at Global IGF.
- To bring together diverse experiences from stakeholders in the fields of ICT and child welfare on policies that have worked to deliver access and learnings on how Internet drives growth and development for our community especially for women, youth and marginalised groups.
- To advance internet governance issues in Mauritius through a multi-stakeholder framework as well as facilitating partnerships and coalitions that deliver coordinated domestic responses, initiatives, and synergies,

- To draw knowledge, wisdom, and expertise of stakeholders in Mauritius to provide insights to the whole Internet community and to focus on the challenging issue of online child safety.
- Create awareness on existing national, regional and Africa wide legislative framework

Mauritius-Internet Governance Forum, 2017



Mauritius Internet Governance Forum's first annual meeting held in Mauritius in November 2017. This one-day meeting on 16th November had as main theme: 'Enhancing Digital Trust to Encompass Online Child Safety'.

This Summit was hosted and spearheaded by Halley Movement

This initiative, also highlighted the contribution of Internet Child Safety Foundation and its research study conducted earlier on 'Impact of Internet on children and young people' The recommendations of the study, acknowledged by the Mauritian cabinet, were at the origin of the setting up of a child safety online committee at the Ministry's level in Mauritius.

The Forum recognised the following:

- Children at a tender age of 3 only are spending increasing time online. Evolution and development in Internet technology gadgets caused a shift in children's internet usage as easy access is now readily available – to all kinds of information: positive and negative contents.
- Internet has become an essential tool regarding the education, entertainment and social -development of the child. Yet, it also carries a spectrum of risks to which children are more vulnerable than adults: online child sexual abuse, online harm from content, antisocial behaviour, contact risks and privacy risks.
- The importance of co-operation information sharing by all stakeholders concerned with Child Protection Online – in terms of research (surveys, working papers, etc.), development, implementation and assessment of policies on same to better protect our children online.
- The importance of policies which would both reduce online threats to foster a better a safer internet for children and to better equip children to protect themselves from threats that remain.
- The importance of establishing dialogue with the international community in order to come up with effective policies – taking into account cultural differences impacting directly on the increasing internet usage and the risks involved.
